The New York State Department of Environmental Conservation, as Lead Agency, has completed the Final Environmental Impact Statement (FEIS) for the above-referenced project. As noted on the cover page of the FEIS, agency SEQR findings and permit decisions must await the passage of a minimum 10-day period in accordance with 6 NYCRR § 617.11(a), which is June 11, 2018. After this date, the DEC anticipates issuing SEQR findings and agency decisions.

By copy of this letter, and in accordance with the distribution requirements in 6 NYCRR §617.12(b) we are also providing this notice, a hard copy of the FEIS Narrative and an electronic (CD) copy of the FEIS and all corresponding appendices, as noted in the distribution list on page 2 of this letter.
